Luncheons & Programs:

Chair of Luncheon and Programs Committee, Sue Jiles, would like to remind members that it is urgent to get luncheon reservations in by the deadline before each luncheon meeting. Typically the deadline is noon on the Monday before the meeting, but this can change depending on the venue.

Many of our venues charge a fee for their meeting rooms. We have negotiated with them to waive that fee by guaranteeing that those present will be a paid lunch. So if you miss the deadline and offer not to eat, it doesn't accomplish anything. If you are there, we have a lunch for which to pay.

Also, the venues need the count to adequately prepare the correct amount of food and set up the space to comfortably accommodate us. After the count was called in for the December luncheon, an additional 20% of our members and their guests called in with a reservation. It is simply not cost effective for a venue to plan to provide 20% more, and it's not fair to ask them to do so.

We are not trying to embarrass anyone, but the problem has been getting worse! Our meeting does not change—it's the first Thursday of each month, September through May. We are just asking members to be more considerate and reliable in getting their reservations in on time. Please!

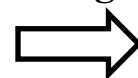

Tony Young will now be the coordinator. He and his wife Sandy have worked graciously in the pantry for several years.

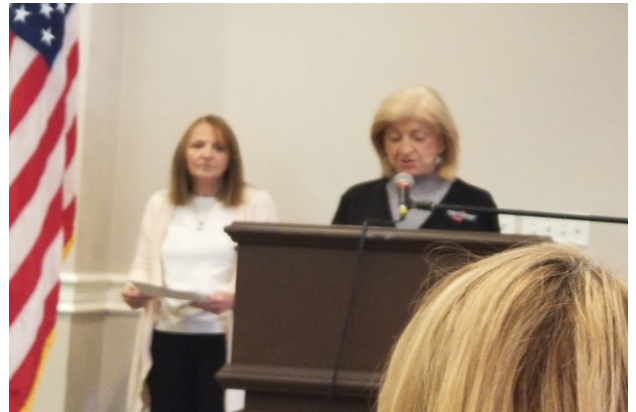


Above are Sandy and Tony Young working in the Food Pantry. Tony is now the new coordinator.
